Dear Glenn,

Since our meeting several months ago, the Y's plans to expand its child care facilities and programs have evolved and improved considerably. But the objective, to serve more children and families in the area while continuing to offer the highest quality of fully certified care, remain unchanged.

As we discussed, the need for substantially more child care in our mid coast area is clearly evident, with inadequate capacity impacting the lives of children, families and employers desperately attempting to fill vacancies. This facility expansion, the first since our current Y opened some 25 years ago, will further add to the YMCA's reputation in mid coast as a great area asset.

The expansion of the Y's early childhood education program will:

- Increase the number of child care slots from 52 to 108
- Increase unduplicated children served annually from 80+ to 170+
- Include critically needed care for infants and toddlers

The Y's basic strategy is to approach this expansion as a coordinated multi-phase process:

- A. First, to create new capacity for 32 preschool children rapidly and provide a phased transition into the much larger program. Plans now call for construction of a "stand alone" two-classroom structure to be built on Y land (between the Y and Little League fields). The new facility will be built within approximately one year costing \$600,000. Having this permanent new facility operational relatively soon will permit child care managers to increase staffing and slots faster. Also important, building this stand alone facility reduces overall construction estimates by \$620,000. The Y anticipates receiving final regulatory approval to proceed with this stand alone facility within a month. In effect, this approach provides the fastest possible expansion, saves money, and allows staffing and child care numbers to be increased gradually compared to the original plan.
- B. An extension attached to the current building for child care will still proceed—but with six classrooms rather than eight. The extension will include those classrooms, furnishings, a kitchen, administrative spaces, increased parking, landscaping, cost

contingencies, fees etc. When completed, Y child care slots will increase to 108, and infants and toddlers will be accommodated for the first time.

C. The combined cost estimate for A and B above is \$7,062,000. Thus far, our very limited requests and quiet fundraising surveys, coupled with two highly probable government grants, have secured commitments and probable donations of \$2,846,000.

Aware of the great need and confident the total goal can be reached, we are accelerating and broadening the quiet campaign. Although our first step described above will proceed now, our objective is to complete the total fund raising challenge quantified above within one year, enabling construction of the Y's child care extension to get underway with no delays.

Bath Savings Institution and the Bath Area Family YMCA have maintained a wonderful business and community focused relationship for decades—to the great benefit of mid-coast Maine citizens. I am writing today to ask if you will please consider making a commitment of \$300,000, payable over three years, to this campaign.

Included with this letter is more detailed information pertaining to the Y's planned expansion. Please contact me if further data would be helpful or if you or your staff would like to meet with those who have been deeply involved with the development of this project.

I'm contacting you to request that Bath Savings consider support for our organization's "Fuel for Friends" program for 2024. Your donation for 2023 was \$3,000.

We would be appreciative of any support you can provide as fuel costs are running very high this year and much of the COVID assistance provided during the past three years is no longer available, making our program very important for those in need.

In 2023, we used a total of \$11,500 provided by our four local financial institutions to setup a "challenge" to our organization's donors to give. With this challenge, we had numerous donations from the community including many first time donors. All together we were able to provide \$20,000 of assistance locally to those in crisis.

As a reminder, The Corporal Works of Mercy(CWOM) Society of St. Mary's Church is a 501(c)(3) non-profit that was established in 1930 by local business people who were parishioners of St. Mary's Church. CWOM was founded following the great depression of 1929 to assist needy widows and families who had the most fundamental needs such as food, housing, clothing and heat. At that time, there were no social service agencies and it was truly neighbors helping neighbors. Without the help provided, many would have gone without food, housing and heat. Our mission today remains unchanged.

Today our organization exist to help people in the greater Bath Area(Bath, Woolwich, Georgetown, Arrowsic, Phippsburg, West Bath, Dresden, Wiscasset) who have immediate need for heating assistance. While we have roots in St. Mary's Church, our funds are distributed throughout the community with no consideration of religious beliefs or church affiliation. Those in need are provided assistance no more than once per year. We work with Midcoast Maine Community Action to screen applicants and disburse funds under guidelines we provide. We typically provide assistance that averages \$500 to approximately 40-50 families per year with this program. Often this covers 100-150 gallons of fuel oil for someone who is totally out. Our organization is 100% volunteer run and we have no rent or staff salaries.

Your organization will receive positive recognition with a broad base of the Bath Area who donate. Please let us know if we can count on your support by March 1<sup>st</sup>, 2024.
